

The 2019 NUS Enterprise Summer Programme on Entrepreneurship will be held from 14 - 27 July 2019.


Applications are now open from 5 March to 12 April 2019!

Singapore has birthed a wide array of home-grown enterprises that leave footprints in the region and beyond. Its success stories include enterprises like Carousell, Shopback, Rotimatic, Patsnap and many more. What is the secret sauce to Singapore's entrepreneurs? You will find the answers at NUS Enterprise's annual Summer Programme, which has been running for the past 13 years.

Over two weeks, this residential programme offers a one-of-a-kind opportunity for local and international students to have an immersive experience of entrepreneurship by inspiring your entrepreneurial imagination and enhancing your entrepreneurial skills. Through an enriching combination of lectures, conversations with startups, ideation and pitching sessions, as well as visits to business and government organisations, our Summer Programme aims to provide you with a comprehensive educational experience.

The programme is also designed to enrich your cross-cultural learning, and strengthen the development of your social capital through the relationships you form over the two weeks.



Programme Details

The NUS Enterprise Summer Programme on Entrepreneurship is targeted at undergraduate students* currently enrolled in university, majoring in any discipline.

*Priority consideration will be given to students with a basic interest in entrepreneurship.

Our programme broadly covers the following topics:

 - Singapore's Economic Development Model and the Changing Role of Entrepreneurship and Innovation
 - The True Singapore Story (introduction to Singapore's heritage)
 - The Heart of Singapore's Startup Ecosystem

 - Experiential introduction to Singapore
- · Practical insights and skills for aspiring entrepreneurs
 - How to be an Entrepreneur
 - Lean Startup and Business Model
 - Pitching and Team Project
- · Themes in entrepreneurship

Lectures will be conducted in English by faculty members from the National University of Singapore and industry experts.

Before you Apply

Can I Apply?

Students who wish to apply for the NUS Enterprise Summer Programme are required to do their groundwork before applying, to find out if they meet the eligibility requirements, as well as the financial costs involved.

Eligibility Criteria

The NUS Enterprise Summer programme is opened to all students from all institutions and universities, and the program is taught entirely in English.

In order to take part in the Summer programme, you must:

- · be currently enrolled in an accredited college or university
- · be proficient in the English language

English Proficiency

If English is not your home university's primary language, you are required to upload your English proficiency document during your application. We shall deem that students nominated are suitable to come on exchange and would be able to cope with the rigorous curriculum conducted in English at NUS Enterprise.

Based on our requirements, please refer below as a guideline for a student to cope with studying at NUS Enterprise:

Please note that only C1 Advanced / Cambridge English: Advanced, TOEFL and / or IELTS scores obtained in the two years leading up to 1 March of the year of application will be considered. For instance, for applications closing on 1 March 2019, the validity period for the scores is from 1 March 2017 to 1 March 2019 (both dates inclusive).

Accommodation and Arrival Information

Accommodation and Arrival Information

- 1. It is compulsory for students to be housed in on-campus accommodation allocated to them.
- While there are a few meals provided and no fully equipped kitchen at the hall for students to cook their meals, students can purchase economically-priced meals at any one of the numerous convenience stores or food outlets located around NUS.
- 3. Self-selection and changing of rooms is not allowed.
- 4. It is recommended for Summer students to check-in to their allocated Hall of Residences on the day of allocation check-in. The check-in for the programme will be on 14 July 2019 and check-out on 27 July 2019.

- 5. Check-ins at the Hall of Residences are available on 14 July 2019, from 8am to 5pm only. Students who are arriving earlier or leaving later then the stipulated check-in and check-out timings are required to source for temporary off-campus housing.
- 6. Students who are intending to arrive before the notified check-in date, or stay in Singapore beyond the notified programme end-date will need to source for their own accommodation, as the period of stay in the Halls of Residence in NUS is strictly from 14 to 27 July 2019 as stipulated in the Letter of Enrolment.

1. I am a high school student / graduating senior / working adult. Am I eligible for the programme?

The NUS Enterprise Summer Programme is designed for undergraduate and post-graduate students *currently enrolled in a university (from any discipline)*.

You may also apply if you are:

- A high school graduate, starting your first year of university immediately after the Summer Programme
- A final year student graduating in the year the Summer Programme takes place
- A graduate student enrolled in the university

Please note that priority consideration is given to current undergraduates and post-graduates.

Working professionals who are currently not enrolled in the university are unfortunately not eligible for this programme.

2. What documents do I need to submit during application?

You will need to submit the following documents:

- A copy of your Passport page which shows your name and nationality.
- A copy of your Academic Transcript with grade legend issued by your Home University (with English translation, if applicable).
- Financial Documentary Proof in English.

- A letter from your Home University certifying that you are a current student registered with the University.
- A copy of your English Language requirement, if your Home University medium is not in English.
- A PDF copy of a fully answered questionnaire.

3. What will I get out of the NUS Enterprise Summer Programme on Entrepreneurship?

4. How many students will be in the Summer Programme?

The 2018 NUS Enterprise Summer Programme on Entrepreneurship hosted 100 local and international students. These students come from a diverse range of nationalities and academic backgrounds.

5. What items should I bring?

A list of recommended items for students to bring during their stay here can be found below:

- Shower toiletries bag or bucket
- Personal toiletries
- Towels, washcloths (recommended 2 sets for changing)
- Shower footwear (e.g. slippers)
- Single-size bed linens, blanket, pillow, pillow cases
- Laundry bag and detergent
- Laptop and charger
- Universal Plug Adapter
- Padlocks (Students are advised not to leave any valuable items in the room or lock their valuables away safely while they are not in the room)

6. Visa related enquiries

Entry Visa

Entry visa is required for international students from some countries for entry into Singapore.

Visit the Singapore Immigration and Checkpoint Authority (ICA) website here (http://www.ica.gov.sg/) to find out which country requires an Entry Visa into Singapore. Students from India and China are required to apply for an Entry Visa prior to entry into Singapore.

Your Entry Visa will enable you to undertake a course of study of not more than 30 days (applicable to the 2-week summer programme) without the need for a Student Pass (STP).

Entry via Social Visit Pass (SVP)

A student who is attending one course of study only, with a duration of 30 days or less, would be able to enter Singapore for the duration of the course on a Social Visit Pass (SVP). However, if the nationality of the student falls under the list of countries of that require an Entry Visa, they are required to apply for it at the ICA website (https://www.ica.gov.sg/visitor/visitor_entryvisa) first. Visit the Singapore Immigration and Checkpoint Authority (ICA) website here (http://www.ica.gov.sg/) to find out whether you are of a nationality which requires an Entry Visa into Singapore.

The SVP will be issued and stamped on the student's passport upon his/her entry into Singapore at the airport customs.
